- Operate a smartphone without the need to see or read what is displayed on the screen.
- Read RSS news feeds and navigate YouTube entertainment content using high-quality text-to-speech voices.
- Receive GPS-based navigational assistance while driving or walking.
- Identify and locate items around the home and the workplace.

According to data from the [Wireless Rehabilitation Engineering Research Center](#), more than 80 percent of people with disabilities own or have access to a wireless communications device. Using Sprint accessibility ID packs allows them to more easily and fully use their devices, often in ways that weren't previously possible.

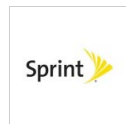

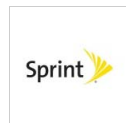

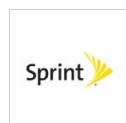
